**Kellogg Grant**  
Purpose: Analyze state commissioned education finance report and identify next steps needed to provide policy makers & public the information necessary for Pk-12 school finance policy reform. Identify a qualified and experienced contractor to conduct a school funding adequacy study using multiple methodologies. The study to be conducted shall provide the information policy makers need in order to ensure that the needs of at-risk and other vulnerable students are prioritized and elevated equitably in new revenue/funding formulas for public education. The Kellogg Grant was awarded to Oakland Schools Education Foundation in order to continue with the previous year program services (Adequacy Study) efforts.  
The goals that were established and met for this grant were as follows:  
Sustain a statewide communications effort, provide funding support for a public education committee chairperson to lead the communications, and conduct focus groups and statewide polling regarding the need for school finance reform.  
The breakdown of expenses: \$188,941 for Professional Services from Outside Contractors, \$3,024 for Operational Expenses such as printing, supplies, web host fees, and \$435 for travel-related costs.

**4b** (Code: ) (Expenses \$ 85,935 including grants of \$ 85,935) (Revenue \$ 85,935)  
**Margaret Dunning Foundation Grant**  
Purpose: purchase state-of-the-art, new and emerging industry-relevant equipment for five high schools and ten technical campus programs within the automotive classrooms. This purchase directly affected over 750 automobile technician high school students within Oakland County. All of these state-approved Career and Technical Education programs are accredited by the National Automotive Technicians Education Foundation (NATEF), which enables students to qualify for Automotive Service Excellence (ASE) certification upon completion of the curriculum. Students earning ASE certifications are directly employable in Maintenance and Light Repair or may move on to post-secondary automotive technology education.  
The breakdown of expenses: \$85,935 in grants to five high schools and ten technical campus programs within Oakland County were provided with this grant.

**Tomorrow's Talent Today Program**  
Purpose: This scholarship program is available to graduating seniors of the Oakland Schools Technical Campuses, by providing scholarship awards to help with their continuing education beyond high school. This program rewards students who have shown teamwork and involvement in extra-curricular activities and have good academic achievement within technical fields taught at the campuses. This program provided scholarships and had a small breakfast to serve as an award ceremony.  
The breakdown of expenses: \$56,022 in grants to graduating seniors of the Oakland Schools Technical Campuses, \$1,391 for Operational Expenses such as, postage, printing, supplies and meals.
